Program Notes

Serenade is an arrangement of Mozart's Divertimento No. 3 by R. Winston Morris. This transcription for tuba was conceived due to the lack of literature for the instrument from the Classical period. The original composition was intended for ten winds: oboe, clarinet, english horn, french horn, and bassoon with 2 players per part. It was later adapted as a Serenade for alto recorder and piano but was also intended for use by other instruments, such as violin, oboe, and flute along with piano.

Suite for Unaccompanied Tuba, dedicated to Rex Connor, tuba instructor at the University of Kentucky, is of particular interest because it is the first number to be written for tuba without. Each of the four movements, Intrada, Valse, Air, and Galop, are short and, except for Air, have a humorous connotation. Although the medium is monophonic, tonality and harmonic progression is always obvious. Walter S. Hartley, composer of Suite for Unaccompanied Tuba, held the position of associate professor and chairman of the music department at Davis and Elkins College.

Where Corals Lie is a song from the vocal song cycle, Sea Pictures, by Edward Elgar. The cycle consists of five songs with text stemming from various poets. Sea Pictures was originally set for contralto and orchestra, but Elgar also wrote an adaptation for voice and piano; both versions are often performed by mezzo-sopranos.

Concertpiece No. 1 was composed by Rodger Vaughan. Vaughan, a native of Kansas, received his Bachelor of Music Degree from the University of Kansas, his Master's Degree in music from Wichita State University, and did additional doctoral studies at the University of Southern California where he studied composition with Ingolf Dahl, orchestration with Halsey Stevens, and tuba with Roger Bobo. He has taught at the University of Wichita, University of Southern California, Upland College, and California State University, Fullerton.
